Court Service Centers

Court Service Centers help people navigate the court system. Centers are open whenever the courts are open, and are available to all court users, with or without attorneys. These centers provide information about which forms should be used to pursue a guardianship and assistance with completing the required forms. There are currently two court service centers: one in Suffolk County and one in Franklin County. Court service centers will be opening in Brockton, Lawrence, Springfield and Worcester soon. • Lawyer of the day programs at Probate and Family Courts.

The Lawyer of the Day provides:

- · Consultation and assistance with completing court paperwork;
- · Does not go into the courtroom to represent litigant;
- No lawyer-client relationship established;
- Cannot assist anyone who is represented by an attorney.
- To see a lawyer of the day on a specific date, you may check with the court that day or the day before to make sure a lawyer is scheduled to appear.
- Free legal help is available at the Suffolk, Middlesex, and Norfolk Probate and Family Courts to low-income people who qualify for legal aid and:
 - are trying to become guardian of a child or an adult who can't care for him or herself;
 - are guardians of child or adult family members and need help with the Care Plans and Annual Reports guardians need to fill out and give to the court.
- One morning a week, lawyers and law students will be at these courthouses to help low-income people:
 - Suffolk County Probate & Family Court in Boston Tuesdays from 9 a.m. to 1 p.m. on the 3rd Floor of the Brooke Courthouse in the hallway outside the Register's office.
 - **Middlesex County Probate & Family Court in Cambridge** Thursdays from 9 a.m. to 1 p.m. on the 2nd Floor of the Courthouse in East Cambridge.
 - Norfolk County Probate & Family Court in Canton Wednesdays from 9 a.m. to 1 p.m. in the Register's office.
