

## Financial Resources for Grandparents and Relative Caregivers

Grandparents raising grandchildren may be eligible for financial resources to help support you in your parenting role. Financial services may be dependent on the custody status, the age of the caregiver, and/or the child's specific needs.

- **Temporary Assistance to Families with Dependent Children (TAFDC) Child Only-Grants**

If you are the guardian of your grandchild through Probate and Family Court, you are entitled to apply for a TAFDC Child-Only Grant through the Department of Transitional Assistance (DTA). The Child-Only Grant is financial support for grandparents and other caregivers caring for children who are not their own. Eligibility is based on your grandchild's income, not yours. You may apply for the TAFDC Child-Only Grant online or in person.

- **Childcare Vouchers**

Working grandparents/relative caregivers who receive the TAFDC Child-Only Grant are eligible for a childcare voucher, speak with your assigned case manager from DTA to make that request. You may also be eligible for childcare vouchers through the Department of Early Education and Care. To apply, visit: [www.mass211.org](http://www.mass211.org)

- **Supplemental Nutrition Assistance Program (SNAP)**

SNAP is a federal nutrition program administered by the Department of Transitional Assistance (DTA). Eligibility **IS** based on your income.

- **Card to Culture Program**

Recipients of benefits from DTA can use their EBT card at various cultural venues for discounted admission.

- **MassHealth**

Your grandchild may be eligible for MassHealth/ Medicaid and other related healthcare benefit programs.

- **Women, Infants, and Children (WIC)**

If your grandchild is under 5 years old, he/she may be eligible for WIC, a nutrition program that provides healthy foods, nutrition education, and other services, free of charge. If you receive WIC, you may also be eligible for discounts on other resources.

- **Social Security Survivor/Disability Benefit**

If either biological parent is deceased, the child may be eligible for survivor benefits through Social Security.

If your grandchild has a medical or mental health disability, they may qualify for disability through Social Security.

- **Aging Service Access Points (ASAP)**

ASAPs provide information and referral services for individuals and caregivers over the age of 55 years old, including grandparents raising grandchildren. Be sure to ask about the Family Caregiver Support Program for potential financial assistance, such as camperships.
